OPERATOR QUALIFICATION

Flawless quality control, strict compliance and professionalism

The Operator Qualification (OQ) Rule is part of the Department of Transportation 49 CFR 192, under the Office of Pipeline Safety. This rule requires natural gas pipeline operators to develop, implement, and maintain a written qualification program for individuals performing covered tasks on natural gas pipeline facilities.

At J.F. Kiely Construction Co., we are committed to and provide a trained, qualified workforce, maintaining records for each team member performing specific covered tasks. Our team members are OQ trained and evaluated by our qualified training staff. As a member of both the Midwest Energy Association (MEA) and the Northeast Gas Association (NGA), we are able to stay current with all Operator Qualification regulatory updates and changes.

In addition to the required OQ training, our team members receive training on OSHA 10, HAZwoper, Respirator, Asbestos, Excavation & Trench Safety, and Confined Space. Routine safety meetings and tool box talks ensure each employee is working in a safe and compliant manner.
